### 2. Provision of Delegate Details

Access to delegate contact details is subject to UK data protection laws and GDPR compliance. UKATA cannot guarantee that delegate information will be available unless explicit consent is given by attendees.

### 3. Unavoidable Occurrences

Should the conference be cancelled, postponed, or rescheduled due to unforeseen circumstances beyond the organisers' control (including but not limited to government regulations, natural disasters, or public health concerns), UKATA shall not be liable for any refund, loss, or damage incurred by sponsors or exhibitors.

### 4. Corporate Recognition

### 7. Cancellation Policy

- 25% cancellation fee if cancelled more than 90 days before the event.
- 50% cancellation fee if cancelled between 60-90 days before the event.
- No refunds for cancellations made within 60 days of the event.

UKATA reserves the right to cancel any sponsorship or exhibition package at its discretion. In such cases, a full refund will be provided.
